Dear All,

Subsequent to the correspondence between NADRA and SECP on verisys related issues of its regulated entities ,NADRA has shown its consent to fully support SECP in its initiatives to implement an effective AML/CFT regime. In lieu of this development all the regulated entities were directed to register with NADRA to avail the Verisys facility(CNIC Verification Services). However NADRA has informed us that a small number of companies has contacted NADRA so far, for provision of Verisys and few companies still have to send back the signed agreement, which had been shared with them earlier.

NADRA has also highlighted the issue that the documents are not being submitted to NADRA for obtaining the verisys facility in accordance with the document checklist (given in the E-Verisys Proposal,attatched above) which results in delays and unnecessary correspondence. NADRA has requested that companies be made aware to submit adequate documents for early access to the verisys facility.

Furthermore, NADRA has conveyed the names and contact details of focal persons appointed as POC to facilitate registered companies;

HOW TO USE E-VERISYS

Please provide all requested documents and sign the contract for provision of service. It is mandatory for an E-Verisys user to register on NADRA Pak Identity Portal individually. The created User ID will be linked-up with the corporate Account of E-Verisys Service with NADRA. The company will provide the information of E-Verisys user id's which needs to be linked with its corporate account to NADRA. NADRA will activate the created account accordingly
