Reference is made to your notice PSX/N-661 dated June 01, 2021, enforcing the compliance of Clause 4.25 of Pakistan Stock Exchange (PSX) Rule Book in respect to the subject certification to be submitted to the Exchange till October 31, 2021.

Needless to mention here that the Securities Brokers have selected their Back Office Software Vendors in line with the List of Eligible Vendors duly approved by the Exchange and published on its website to follow the same. It is worth pointing out that instead of requiring the certificates from all the 200 Securities Brokers, the Software Vendors may be directed in order to observe a one-stop solution, to ensure that the systems are in place as per the standards of Broker Back Office System and Information Security Requirements.

You may please acknowledge that the subject requirements will turn into a huge cost impact when it comes to the entire industry.

Therefore, it is humbly requested to kindly take up the matter with the authorities, considering the concerns of our members as discussed above, so that the requirement is met more easily and quickly.

Dear Mr. Bilal,

This is with reference to your letter No. PSBA/P0621-01 dated June 10, 2021 in relation to the subject matter.

At the outset, we would like to inform that every TRE Certificate Holder is required, under Clause 4.25 of PSX Regulations, to have regular testing including vulnerability assessment and penetration testing conducted of its back office software / application and undergo certification requirements as prescribed by PSX. Further, under the said Clause, the TRE Certificate Holders are also required to submit with PSX, an audit report and a certificate of the auditor for appropriateness of necessary controls and safeguards put in place in relation to information security arrangements.

As you are aware that these regulatory requirements are in place since June 2016 and it is imperative for every TRE Certificate Holder to comply therewith to ensure consistency of reporting standards across the brokerage industry.

In view thereof and also considering the fact that PSX does not regulate the vendors of brokers' back office system, it is reiterated that the TRE Certificate Holders comply with the requirements notified vide PSX Notice No. PSX/N-661 dated June 01, 2021 issued under Clause 4.25 of PSX Regulations.

Dear Sir,

Reference is made to the captioned subject, it is to submit that in pursuance of the notice published by Pakistan Stock Exchange PSX/N-661 dated June 01, 2021, we had made a representation with the Exchange authority to seek relaxation apprising of the difficulties and a huge cost impact if it is enforced to the entire industry. Subsequently, the Exchange responded that all the TREC Holders have to mandatorily comply with the requirement of Clause 4.25 of PSX Regulations (copies enclosed).

Now, therefore, your good office is requested to kindly intervene in the matter and the Exchange authority may please be directed to enforce the compliance with some alternate and short method instead of going for all the 200 stock brokers, as requested in our aforesaid letter.

This relaxation will certainly provide ease to the brokers, and will also save cost for an audit of the system provided by the software vendors, already approved by the Exchange itself.

Moreover, we would like to give a soft reminder to kindly introduce a consolidated audit mechanism for stock brokers so that it will do away with the requirement of multiple audits.
