TRANSACTION CHARGES ON PHYSICAL MOVEMENT

Dear Sir,

At the outset, we appreciate the step that has been taken by reducing the tariff for digital transactions so that the customers can perform their transactions digitally and make payments online seamlessly. This is a great initiative in order to facilitate and promote a paperless environment.

However, for the transactions/functions/reports performed physically after February 14, 2022, CDC is charging Rs.100/- per transaction. In this regard, please note that 100% of the Capital Market Investors are not computer literate, hence, it is quite unjustified for them to be charged higher than the digital means.

Therefore, we request you to kindly waive the charges on physical functions as well, so that to avoid difficulties in any manner.
